
The manuscript focuses on an important topic, namely the evaluation of vertical ozone distributions predicted by various regional chemistry transport models (CTMs). The combined use MOZAIC and IASI data for this purpose is novel, and the authors present a comprehensive analysis of the observed and modeled datasets. I find the manuscript to be well structured and only have a number of minor, mostly editorial, comments.

Abstract: Please spell out all acronyms. For the discussion on lines 1-10, I suggest briefly stating that four of the five regional CTMs used the MOZART IFS boundary conditions, while the remaining CTM (MOCAGE) used a different set of boundary conditions. Regarding the statement on lines 14-15, I suggest stating that the explicit com-

parison of the impacts from using 3-hourly vs. monthly mean boundary conditions was performed with only one (CHIMERE) of the four regional models using MOZART-IFS boundary conditions. In line 15, please be more explicit about what metric was used to determine improved model skill. In line 18, please replace "catched" with "represented"
