Dear Jonas Gliß,

Your manuscript has improved a lot, thanks to the several rounds of substantial discussions, especially helpful comments and suggestions from the referees. The manuscript can be accepted for publican in ACP subject to some technical corrections as described below.

It seems that the instrument was not inside the plume all the way during the experiment.

Answer: It is true, that not all measurements were performed in the plume, however, we wish to remark that still the focus of the study is on the volcanic plume data. We nonetheless followed the editor's suggestions and only changed the wording slightly as given below and we hope, the editor can agree with this.

Therefore, the two sentences in Line 2-4 and Line 43-44 might be rewritten, respectively, as "Spatial and temporal profiles of chlorine dioxide (OCIO), bromine monoxide (BrO) and sulfur dioxide (SO2) in the volcanic plume were investigated at Mt. Etna, Italy, in September 2012 using Multi-Axis-Differential-Optical-Absorption-Spectroscopy (MAX-DOAS)";

Changes to the manuscript: we changed the corresponding sentence to read:

"Spatial and temporal profiles of chlorine dioxide (OCIO), bromine monoxide (BrO) and sulfur dioxide (SO2) of the volcanic plume at Mt. Etna, Italy, were investigated in September 2012 using Multi Axis Differential Optical Absorption Spectroscopy (MAX-DOAS)"

"In this study we present MAX-DOAS measurements (e.g. Hönninger et al., 2004) of the volcanic plumes performed at Mt. Etna on Sicily, Italy".

Changes to the manuscript: we changed the corresponding sentence to read:

"In this study we present MAX-DOAS measurements (e.g. Hönninger et al., 2004) of the volcanic plume at Mt. Etna on Sicily, Italy, performed in September 2012."
